DESCRIPTION

MARCONOL OLIO PAGLIERINO is a clear amber-coloured oil which is suitable for polishing, nourishing and regenerating any type of wood artefacts for indoor use such as furniture, shutters and frames, doors and matchboarding. Non-filmogenous. Ideal for the restoration of antique furniture.

MARCONOL OLIO PAGLIERINO penetrates the fibres of the wood, reviving its colouring and giving the wood pleasant warm tones.

Suitable for oil finishing of wood.

INSTRUCTIONS FOR USE

Can be applied to artefacts in wood, indoors.

TECHNICAL SPECIFICATIONS

- Type of Binder: heavy alchylbenzene based vegetable oils

- Appearance: transparent oily liquid with a colour tending towards yellow
- Flash point: in excess of 155°C
- Drying times (at 25°C and 65% R.H.): minimum 24 hours.

PREPARING THE SURFACE

- The surfaces to be treated must be dry and free of dust and grease.
- Lightly sand down the surface then apply MARCONOL OLIO PAGLIERINO.

APPLICATION INSTRUCTIONS

- Environment and support conditions:
Temperature of environment: Min. $+8^{\circ}\text{C}$ / Max. $+35^{\circ}\text{C}$
Relative humidity of the environment: $<75\%$
Temperature of support: Min. $+5^{\circ}\text{C}$ / Max. $+35^{\circ}\text{C}$
Humidity of the support: $<10\%$
- Tools: brush
- No. of coats: 1
- Product ready to use.
- Application procedure:
After applying MARCONOL OLIO PAGLIERINO, wait at least 24 hours to give it time to be absorbed. Then, before using other products, clean the treated surface with a dry cloth to remove the excess oil not absorbed by the wood.
- Cleaning of tools: immediately after use with White spirit 5200010 or Synthetic thinner 5210011.
- Indicative spreading rate: 12-15 m²/l per coat

STORAGE

Maximum temperature for storage stability: $+30^{\circ}\text{C}$
Minimum temperature for storage stability: $+5^{\circ}\text{C}$
The product should be preferably used within 2 years from date of manufacture when stored in original unopened

containers and in appropriate temperature conditions.
